DESCRIPTION OF REPORT

SCOPE:

The "FEC Reports on Financial Activity-Presidential Pre-Nomination Campaigns" is a summary of the campaign finance activity of major Presidential candidates involved in the 1988 primary election process. Specifically this report provides information on the financial activity of the prenomination campaigns of those individuals who 1) have registered under the Federal Election Campaign Act as a candidate for nomination to the Office of President of the United States and 2) have reported total receipts or total disbursements in excess of \$500,000.

The activity listed for each primary campaign includes all receipts and disbursements reported to the FEC by the Presidential candidates, their principal campaign committees and any other committees the candidates authorized for the 1988 primary election.

The report also covers activity undertaken on behalf of a primary candidate but which is not authorized by him/her. Such activity is shown under separate, specific columns. One column, for example, shows independent expenditures, while another displays communications costs.

SOURCE OF INFORMATION:

Most of the information included in this report was taken from the reports filed, on FEC Form 3P (with supporting schedules), by the authorized committees of Presidential candidates. However, that information pertaining to independent expenditures, delegate/delegate committee disbursements, and communications costs was taken from reports submitted by persons engaged in these particular types of activity.

Information on receipts and disbursements from reports filed with the Commission was entered into the Commission's computer system. Programs that summarize this information were used to produce the TABLES included in this report.

Available for inspection at the Commission are microfilmed copies of the original reports filed with the Commission. The microfilmed public record is the official record of the Federal Election Commission.

PERIOD COVERED:

This report covers the period beginning in 1985 when Presidential primary candidates first began filing campaign finance reports with the Commission. As subsequent reports pertaining to 1987-88 activity were received during 1986, 1987, and 1988, the dollar figures contained in them were entered into the computer system and added to earlier information. This final report includes information through December 31, 1988. Appendix I contains additional information reported by candidates in 1989.

DESCRIPTION OF REPORT

The computer programs which produced the TABLES in this report were run on June 20, 1989 and used all reports covering the period through December 31, 1988 which had been filed and processed at the Commission by that date. (Data in TABLE A5 on primary matching fund activity, however, is current through July 25, 1989.)

LIMITATIONS:

This report is a final report, based on information which the Commission has received and processed to date. The information may be subsequently amended by the candidates and committees or corrected by the Commission when during normal verification and review, it discovers processing errors.

Available at the Commission for inspection are microfilmed copies of the original reports which show information as reported by the filers. The microfilmed public record is the official record of the Federal Election Commission. This report is one of several tools which have been developed to summarize the vast quantity of data available on the microfilmed public record. The TABLES are designed to provide information on the financial activity of the prenomination campaigns included in this volume. The EXPLANATION OF COLUMNS provides detailed definitions of columns and explanations of organization; it should be used in conjunction with the TABLES.

TABLES AI-A9FINANCIAL ACTIVITY OF
SELECTED PRESIDENTIAL PRE-
NOMINATION CAMPAIGNS

These nine TABLES provide receipt and disbursement information on the pre-nomination campaigns of those individuals who l) have registered under the Federal Election Campaign Act as a candidate for nomination to the Office of President of the United States and 2) have reported total receipts or total disbursements in excess of \$500,000. The campaigns are divided into three categories: Democratic, Republican and Other. Within each category, the candidates' campaigns are listed alphabetically. The candidate's party affiliation is reported on his/her Statement of Candidacy (FEC Form 2) filed with the Commission. Total receipts and total disbursements are not necessarily accurate reflections of the actual money that is available to and spent by a primary campaign. These figures may be inflated when they include transfers between committees within the same campaign (authorized committees within a single campaign). So that these internal transfers will not be counted twice, they have been subtracted from total receipts and from total disbursements to provide net receipts and net disbursements. It is these two columns which most accurately depict receipts and disbursements.

TABLE AL RECEIPTS

This TABLE divides TOTAL RECEIPTS into various subcategories such as OFFSETS TO OPERATING EXPENDITURES and TOTAL INDIVIDUAL CONTRIBUTIONS.

TABLE A2 ADJUSTED RECEIPTS

This TABLE adjusts certain receipt categories for refunds or repayments made by the campaign.

For example, it shows loans received from or guaranteed by the candidate minus any repayments of these loans made by campaign com mittees.

TABLE A3 CONTRIBUTIONS FROM INDIVIDUALS

This TABLE shows a breakdown of the TOTAL INDIVIDUAL CONTRIBUTIONS to a campaign. The TABLE includes the total amount of contributions from individuals by the size of each contribution. Also shown is the amount refunded to individuals by the campaign.

TABLE A4 CONTRIBUTIONS FROM POLITICAL COMMITTEES

This TABLE shows details of net contributions which the campaign has received from party and non-party committees. The amount of net contributions from political committees is equal to total contributions from political committees minus ite mized refunds of contributions which the campaign has made to party and non-party committees.

TABLE A5 PRIMARY MATCHING FUND ACTIVITY

This TABLE shows the primary matching fund certification activity for those campaigns receiving Federal matching funds.

TABLE A6 DISBURSEMENTS

This TABLE shows TOTAL DISBURSEMENTS, dividing them into several categories such as ITEMIZED LOAN REPAYMENTS TO THE CANDIDATE, and OPERATING EXPENDITURES.

TABLE A7 ADJUSTED DISBURSEMENTS

This table adjusts certain disbursement categories for offsets or refunds received by campaign committees. Also included here are expenditures subject to limitation along with cashon-hand and debt information for the campaign (limits on expenditures apply only to campaigns that receive Federal Matching Funds.)

TABLE A8 EXPENDITURES, DISBURSEMENTS AND COMMUNICATION COSTS BY OTHERS

This TABLE shows expenditures, disbursements and communications costs for and against the campaign, as reported by non-party committees and other persons filing reports with the Commission.

TABLE A9 STATE-BY-STATE EXPENDITURES

This TABLE shows, for campaigns that are eligible for matching payments, the state-by-state expenditures subject to limitation.

TABLE B DATE OF CONTRIBUTIONS BY POLITICAL COMMITTEES

This TABLE shows, for each of the campaigns with at least \$10,000 in contributions from non-party or party committees and for all campaigns taken together, the amount of support from 1) party

committees and 2) different types of non-party committees, such as corporation-connected or labor-connected political committees, along with the timing of that support within the primary campaign period.

There is a separate page for each of the campaigns (see TABLE B for description), and one for all Presidential campaigns.

TABLE C INDIVIDUAL CONTRIBUTIONS AGGREGATED BY STATE

This TABLE shows the distribution of large individual contributions to each campaign by the state address of the contributor. Figures are given for itemized contributions from individuals of \$500or more. The campaigns are displayed individually; and a final column gives figures for all Presidential campaigns.

TABLE D NET RECEIPTS OF CAMPAIGNS BYTIME PERIOD

This TABLE lists for each campaign, net receipts as reported by the Principal Campaign Committee and any authorized committees by the time period covered for each report, i.e. for each quarter of 1987 and month of 1988. (Note that some campaigns were not active during all of 1987 and so have no activity during some time periods.)

TABLE E TOTAL INDIVIDUAL CONTRIBUTIONS BY TIME PERIOD

This TABLE shows for each campaign the total individual contributions reported by the campaign by the time period covered for each report. It also provides the percent of net receipts for the period represented by total individual contributions. (Note that some campaigns were not active during all of 1987 and so have no activity during some time periods.)

TABLE FTOTAL LOANS RECEIVED BYPERIOD

This TABLE lists the total loans received by each campaign by the time period covered for each report, in dollars and as a percent of net receipts. (Note that some campaigns were not active during all of 1987 and so have no activity during some time periods.)

TABLE G FEDERAL MATCHING FUNDSRECEIVED BY TIME PERIOD

This TABLE presents the total of Federal matching funds received by each campaign accepting matching funds by reporting period in 1988.

TABLE HNET DISBURSEMENTS OF CAMPAIGNSBY TIME PERIOD

This TABLE provides the net disbursements of each campaign by period covered for each report during 1987 and 1988. (Note that some campaigns were not active during all of 1987 and so have no activity during some time periods.)

This section explains the special terms that appear as labels of the different columns, how the amount is derived for each column and, where appropriate, the significance of the column. Words included in this section are listed in the order in which they appear in each table. For example, the column in TABLE A2, labeled FEDERAL MATCHING FUNDS, appears under TABLE A2, as the first entry. Readers are encouraged to consult this section regularly as they use the report.

Readers should be aware that the terms as used in this report may be defined differently than they are in the Federal Election Campaign Act of 1971, as amended.

In addition to explaining terms, the EXPLANATION OF COLUMNS indicates the line number and (where appropriate) the schedule letter of the FEC Form 3P on which the receipt and disbursement information was reported.

TABLE A1 - RECEIPTS

CANDIDATE:

TABLE A provides information on the prenomination campaigns of those individuals who 1) have registered under the Federal Election Campaign Act as a candidate for nomination to the Office of President of the United States and 2) have reported total receipts or total disbursements in excess of \$500,000. The candidates' campaigns are listed in alphabetical order within a party grouping. The candidate's party affiliation is reported on his/her Statement of Candidacy (FEC Form 2) filed with the Commission.

TOTAL RECEIPTS:

This column includes all incoming monies, goods and services reported on Line 7, by the committees authorized for each 1988 primary election campaign. (It does not include receipts of campaign committees authorized by the candidate in conjunction with a previous or subsequent Federal election.)

NET RECEIPTS:

This column shows the actual receipts of all committees a candidate has authorized for the 1988 primary campaign. It is equal to total receipts reported by those campaign committees minus any transfers they have received from each other. ("Transfers", reported on Line 18 of Schedule A, are the movement of money, goods, property or services between authorized committees of a single Note that, if a joint fundraising campaign.) committee or a campaign committee that was authorized by the candidate for another Federal campaign transfers funds to a 1988 primary campaign committee, the transaction is regarded as contribution another non-campaign а from committee, not as an internal transfer.

OFFSETS TO OPERATING:

This column represents all refunds or returns of disbursements made by the campaign for operating expenses. They include such things as returns of deposits on office equipment. The amounts are reported on Line 20a, Column A.

OFFSETS TO FUNDRAISING:

This column shows the total amount of refunds, rebates, etc. of disbursements made for certain fundraising activities which may be exempt from expenditure limits (see 2 U.S.C. Section 441a(b) and Section 431(9)(B)(vi)) Information is reported on Line 20b. For example, if the cost of fundraising efforts is \$10,000 the amount is exempt from the expenditure limit as long as it does not exceed 20 percent of the overall spending limit. If \$3,000 of the original payment were refunded, that amount would be included in this column. Note that fundraising disbursements are not required to be isolated on Line 25. They must appear on this line, however, if they are to be considered exempt from expenditure limits.

OFFSETS TO LEGAL/ACCT:

Included here is the total amount of refunds/rebates, etc. of disbursements made for legal or accounting fees which are exempt from expenditure limits (see 2 U.S.E. 441 a(b) and Section 431(9)(B)(vii)) They are reported on Line 20c, Column A. Note that legal or accounting

disbursements are not required to be isolated on Line 26. They must be reported here, however if they are to be considered exempt from expenditure limits.

FEDERAL MATCHING FUNDS:

This column shows the amount of Federal matching funds certified by the FEC and received by the candidate during 1988 from the U.S. Treasury, as reported by the campaign on Line 16, Column A of 1988 disclosure reports.

TOTAL INDIV CONTRIB:

This figure represents all itemized and unitemized contributions from individuals, as reported on Line 17a, Column A. (Checks for individual contributions that banks returned to the campaign because of "non-sufficient funds" have been reported, by some campaigns, as negative receipts and thus netted out of the total individual contribution amount.) As used in this study, contributions from individuals include monies given to the campaign or earmarked through political committees and in-kind contributions of services, goods or property. (Note that itemized loans received from individuals are included under the column labeled OTHER LOANS.)

CONTRIB FROM CANDIDATE:

The figure is the sum of itemized contributions from the candidate to the campaign.

LOANS FROM CANDIDATE:

This figure is the amount of itemized loans which a campaign has received from the candidate, as reported on Line 19a of Schedule A.

OTHER LOANS:

This column shows loans received from individuals, from candidates and political committees, from organizations which are not registered under the Federal Election Campaign Act, and from banks in the ordinary course of business. Line 19b Column A is the source.

OTHER RECEIPTS:

The final column of detailed receipts shows the total amount of other receipts which have been disclosed on Line 21, Column A, of the campaign's reports.

TABLE A2 - ADJUSTED RECEIPTS

FEDERAL MATCHING FUNDS:

This figure is the same as that appearing in Table AL.

INDIVIDUAL CONTRIB MINUS REFUNDS:

This column represents the sum of the itemized and unitemized contributions from individuals reported on Line 17a, Column A, of each report filed for the campaign minus any refunds of

Individual Contributions as reported on Line 28a, Column A.

PARTY CONTRIB MINUS REFUNDS:

The amount given here is the sum of all contributions which the campaign has received from party organizations as reported on Line 17b minus any refunds of these contributions reported on Line 28b.

OTHER CMTE CONTRIB MINUS REFUNDS:

This column provides the total amount contributed to the campaign by non-party and other committees outside the campaign as reported on Line 17c, Column A, minus any refunds of the contributions reported on Line 28c, Column A.

CANDIDATE CONTRIBUTIONS:

This column shows the total amount of contributions made by the candidate as reported on Line 17d, Column A.

CANDIDATE LOANS MINUS REPAYMENTS:

This figure represents the total amount of loans received by the campaign which were made or guaranteed by the candidate as reported on Line 19A, Column A, minus any repayments of these loans reported on Line 27a, Column A.

Such contributions, reported on Line 17d, Schedule A, may be either cash or in-kind contributions of services, goods or property. (Note that itemized loans received from the candidate are shown under the column LOANS FROM CANDIDATE.)

TOTAL PARTY CONTRIB:

The amount given here is the sum of all contributions (donations of money or in-kind contributions of services, goods or property) which the campaign has received from party organizations. (A party organization means any group that is part of the official party structure at the national, State or local level, which may or may not be registered as a political committee under the Federal Election Campaign Act, as amended.) Such receipts are reported on Line 17b, Column A. (Note that any loans received from party organizations are included in the column labeled OTHER LOANS.)

TOTAL NON-PARTY CONTRIB:

This column shows the sum of all contributions (donations of money or in-kind contributions of services, goods or property) which the campaign has reported receiving from non-party committees, (A non-party committee means any committee that has not been authorized by any candidate and is not part of the official party structure at the national, State or local level, which has registered as a political committee under the Federal Election Campaign Act, as amended.) Such receipts are reported on Line 17c of Schedule A. (Note that any loans received from non-party committees are included in the OTHER LOANS category.)

CONTRIB FROM OTHER COMM:

This column shows contributions (donations of money or in-kind contributions of services, goods or property) received from all other committees not accounted for in previous columns. Amounts are determined by subtracting, from the total amount of contributions received from other political committees (Line 17c, Column A) the total nonparty contributions displayed in the previous This column may include contributions column. from political committees authorized by other candidates for Federal office, contributions from political committees authorized by the same candidate in conjunction with a previous candidacy for Federal office, contributions from joint fundraising committees, and contributions from unregistered com mittees.

\$750 & UP CONTRIB (Itemized \$750 & Up Contributions from Individuals):

The amount is the sum of itemized contributions of 750-and-up from individuals. The source is Line 17A of Schedule A. The definition of a contribution and the requirements for itemization are given above in 1 - 499 CONTRIB, as is the function of the percentage.

TOTAL INDIV CONTRIB:

This amount, the sum of the previous three columns, represents the total amount of itemized and unitemized individual contributions (from Line 17a, Column A.)

REFUNDS OF CONTRIB:

This amount helps give an accourate picture of the individual contributions actually received and accepted by the campaign. The figure includes the amount of any refunds of contributions to individuals which the campaign has reported making on Line 28a, Column A. In addition, checks for individual contributions that banks returned to the campaign because of "non-sufficient funds" have been reported, by some campaigns, as disbursements for contribution refunds on Line 28a, Column A.

TABLE A4 - CONTRIBUTIONS FROM POLITICAL COMMITTEES

NET CORPORATION CONTRIB:

This column shows the amount of contributions (donations of money or in-kind contributions of services, goods or property) received (and retained) from non-party political committees that are connected to corporate organizations. (A non-party committee means any committee that has not been authorized by any candidate and is not part of the official party structure at the national, State or local level, which has registered as a political committee under the Federal Election Campaign Act, as amended.)

The amount is equal to the total contributions which the campaign has received from corporationconnected committees, minus any itemized contributions the campaign has returned to such committees. Line 17c of Schedule A gives the receipt of the contribution while Line 28c of Schedule B shows the refund. (Loans received from corporate-connected committees are shown in the receipts columns OTHER LOANS.)

NET LABOR CONTRIB:

This column shows the amount of contributions (donations of money or in-kind contributions of services, goods or property) received (and retained) from non-party political committees that are

OTHER LOANS MINUS REPAYMENTS:

The amount here is the total amount of loans received by the campaign which were not made or guaranteed by the candidate as reported on Line 19b, Column A, minus any repayments of these loans as reported on Line 27b, Column A.

OTHER RECEIPTS:

This column is the same as "OTHER RECEIPTS" in TABLE AL.

ADJUSTED CAMPAIGN TOTAL:

This figure represents the sum of the previous eight columns.

TABLE A3 - CONTRIBUTIONS FROM INDIVIDUALS

\$1-\$499 CONTRIB:

This figure is derived by means of subtracting from the total amount of individual contributions reported on Line 17a, Column A, the total amount of itemized \$500-and-above contributions from individuals. This represents both itemized and unitemized contributions of less than \$500 from individuals.

As used in this study, contributions from individuals include monies given directly to the campaign or earmarked through another political committee and in-kind contributions of services, goods or property. (Checks for individual contributions that banks return to the campaign because of "non-sufficient funds" have been reported, by some campaigns, as negative receipts and thus netted out of the total amount of itemized individual contributions.)

Itemized contributions are those which have been identified separately on reports, disclosing the name and address of the contributor, his or her place of business/name of employer and the amount and date of the contribution: Under the Federal Election Campaign Act of 1971, as amended in 1974, 1976, and 1979, contributions from individuals must be itemized if they exceeded (in the aggregate) \$200 per candidate, per year. Once an individual donor's contributions to a candidate exceeded this amount, all subsequent contributions to the same candidate must be itemized. (Note that itemized loans received from individuals are not included here.)

The percentage indicates what portion of total individual contributions consisted of contributions which fall in this dollar range.

\$500 - \$749 CONTRIB (Itemized \$500 - \$749 Contributions from Individuals):

The amount is the sum of itemized contributions of 500 - 749 from individuals. The source is Line 17a of Schedule A. The definition of a contribution and the requirements for itemization are given above in 1 - 499 CONTRIB, as is the function of the percentage.

committees are shown in the receipts columns OTHER LOANS.)

NET COOPERATIVE CONTRIB:

This column shows the amount of contributions (donations of money or in-kind contributions of services, goods or property) received (and retained) from non-party political committees which have reported a connection with a cooperative. (A nonparty committee means any committee that has not been authorized by any candidate and is not part of the official party structure at the national. State or local level, which has registered as a political committee under the Federal Election Campaign Act, as amended.)

The amount is equal to the total contributions which the campaign has received from such committees, minus any itemized contributions the campaign has returned to such committees. Total contributions are disclosed on Line 17c of Schedule A of the campaign's reports, while refunds of contributions are reported on Line 28c of Schedule B. (Loans received from these committees are shown in the receipts columns OTHER LOANS.)

NET CORP W/O STOCK CONTRIB:

This column shows the amount of contributions (donations of money or in-kind contributions of services, goods or property) received (and retained) from non-party political committees which have reported a connection with a corporation without capital stock. (A non-party committee means any committee that has not been authorized by any candidate and is not part of the official party structure at the national, State or local level, which has registered as a political committee under the Federal Election Campaign Act, as a mended.)

The amount is equal to the total contributions which the campaign has received from such committees, minus any itemized contributions the campaign has returned to such committees. Total contributions are disclosed on Line 17c of Schedule A of the campaign's reports, while refunds of contributions are reported on Line 28c of Schedule B. (Loans received from these committees are shown in the receipts columns OTHER LOANS.)

TOTAL NET NON-PARTY CONTRIB:

This column, the summation of the preceding six, shows the amount of contributions (donations of money or in-kind contributions of services, goods or property) received (and retained) from non-party political committees. (A non-party committee means any committee that has not been authorized by any candidate and is not part of the official party structure at the national, State or local level, which has registered as a political committee under the Federal Election Campaign Act, as amended.)

The amount is equal to the total contributions which the campaign has received from non-party committees minus any itemized contributions the

connected to labor organizations. (A non-party committee means any committee that has not been authorized by any candidate and is not part of the official party structure at the national, State or local level, which has registered as a political committee under the Federal Election Campaign Act, as amended.)

The amount is equal to the total contributions which the campaign has received from laborconnected committees, minus any itemized contributions the campaign has returned to such committees. The receipt of the contributions is reported on Line 17a of Schedule A; the refunds of contributions, on Line 28c of Schedule B. (Loans received from labor-connected committees are shown in the receipts columns OTHER LOANS.)

NET NON-CONNECTED CONTRIB:

This column shows the amount of contributions (donations of money or in-kind contributions of services, goods or property) received (and retained) from non-party political committees that have not reported a connected organization. (A non-party committee means any committee that has not been authorized by any candidate and is not part of the official party structure at the national, State or local level, which has registered as a political committee under the Federal Election Campaign Act, as amended.)

The amount is equal to the total contributions which the campaign has received from nonconnected committees, minus any itemized contributions the campaign has returned to such committees. Total contributions are disclosed on Line 17c of Schedule A of the campaign's reports, while refunds of contributions are reported on Line 28c of Schedule B. (Loans received from nonconnected committees are shown in the receipts columns OTHER LOANS.)

NET TRADE/MEMBER/HEALTH:

This column shows the amount of contributions (donations of money or in-kind contributions of services, goods or property) received (and retained) from non-party political committees which have reported a connection with a trade association or a membership organization or which are in the healthrelated field.

(A non-party committee means any committee that has not been authorized by any candidate and is not part of the official party structure at the national, State or local level, which has registered as a political committee under the Federal Election Campaign Act, as amended.)

The amount is equal to the total contributions which the campaign has received from such committees, minus any itemized contributions the campaign has returned to such committees. The receipt of total contributions is reported on Line 17c of Schedule A; the refunds, on Line 28c of Schedule B. (Loans received from trade/member/health

campaign has returned to such committees. The receipt of contributions is shown on Line 17c of Schedule A of the campaign's reports; the refund of the contributions is reported on Line 28c of Schedule B. (Loans received from non-party committees are shown in the receipts columns OTHER LOANS.)

NET PARTY CONTRIB:

This column shows the amount of contributions (donations of money or in-kind contributions of services, goods or property) received (and retained) from party committees. (A party committee means any committee that is part of the official party structure at the national. State or local level, which has registered as a political committee under the Federal Election Campaign Act, as amended.) The amount is equal to the total contributions which the campaign has received from party committees, minus any itemized contributions the campaign has returned to such committees. The total party contributions are disclosed on Line 17b of Schedule A; the refunds of contributions on Line 28b of Schedule B. (Loans received from party committees are shown in the receipts columns OTHER LOANS.) Note: many state and local party organizations are no longer required to register as political Contributions to presidential committees. candidates from these other party organizations do not appear here, but do appear in TABLES Al and A2.

TABLE A5 - PRIMARY MATCHING FUND ACTIVITY

NO. SUBMS CERTIFIED:

This column gives the number of submissions for matching funds made by a campaign which the Commission has certified for payment by the Secretary of the Treasury.

(A submission means the campaign's request for Federal funds to match those contributions (donations of money only) that are eligible for matching payments. A campaign makes such a request by submitting, to the FEC, the eligible contributions it has received. Each submission may contain any number of contributions.) Presidential candidates may make submissions twice each month during their eligibility for matching funds, one of which includes detailed information on each contribution included. Only those complete submissions which have been certified by the Commission are included here.

NO. OF CONTRIBUTIONS ON SUBMS:

The total number of individual contributors on submissions (or on resubmissions which replace a single submission) which the Commission has certified for payment is displayed here and named "number of contributions."

AVER CONTRIB AMT ON SUBMS:

For the complete submissions (or resubmissions replacing a single submission) certified for payment by the Commission the sum of the amounts requested is divided by the sum of the NO. OF CONTRIBUTIONS ON SUBMS to determine the average contribution amount. (See the previous category for a definition of the NO. OF CONTRIBUTIONS ON SUBMS.)

TOT AMT REQUESTED ON SUBMS:

This column shows the total amount of Federal matching funds requested by the campaign on the complete submissions (or resubmissions replacing a single submission) that have been actually certified for payment by the Commission. This amount is calculated by the Commission following its review of submissions.

TOT AMT CERTIFIED FOR SUBMS:

This column shows, for certified submissions, the total amount actually certified for payment by the Commission.

% MATCHED ON SUBMS:

This column shows the total amount actually certified divided by the total amount requested by the campaign.

AMT ORIG NOT CERTIFIED ON SUBMS:

This column shows the amount of contributions (donations of money only) that the FEC has determined to be non-matchable. The figure is equal to the difference between the amount requested and the amount actually certified for matching payment, except where on a final submission only a portion of the matachable value was certified because the maximum entitlement was reached.

NO. RESUBMS CERTIFIED:

This column shows the number of resubmissions and combined resubmissions made by a campaign which the Commission has certified for matching funds.

Note that some types of contributions (donations of money only) which were originally submitted and rejected as non-matchable may be resubmitted with additional necessary information on a resubmission.

TOT AMT CERTIFIED FOR RESUBMS:

This column shows, for certified resubmissions and combined resubmissions, the total amount actually certified for payment by the Commission.

TOT AMT CERTIFIED TO DATE:

This figure shows the total amount (for submissions and resubmissions and combined resubmissions) actually certified for payments.

% MATCHED ON SUBMS/RESUBMS:

This column shows what percentage of total funds requested was actually matched with Federal

funds. The percentage is calculated by dividing the total amount actually certified for payment (for certified submission or resubmissions and combined resubmissions) by the total amount requested (on certified submissions or on single resubmissions.)

TOT AMT REJECTED TO DATE:

This column shows the total amount which, to date, the Commission has rejected for matching funds or for which adjustments were made due to previously matched contributions becoming nonpayable upon deposit (NSF).

NO. SUBMS NOT CERTIFIED:

This figure shows the number of submissions which the Commission received but for which no payment has yet been certified.

NO. RESUBMS NOT CERTIFIED:

This column shows the number of resubmissions and combined resubmissions which the Commission received but for which no payment has been certified.

TOT AMT REQUESTED SUBMS & RESUBMS NOT CERTIFIED:

This figure is the total amount requested by the campaign on the submissions, resubmissions, and combined resubmissions for which the Commission has not certified payment.

TOTAL AMOUNT REPAID:

This column indicates the total amount of Federal matching funds that the candidate has returned to the U.S. Treasury. A repayment may occur if the Commission determines, as a result of an audit or other examination, that a repayment of Federal matching funds is necessary.

TABLE A6 - DISBURSEMENTS

TOTAL DISBURSEMENTS:

This column includes all outgoing monies, goods and services reported on Line 9, by the committees authorized for a particular 1988 primary campaign. (It does not include disbursements made by campaign committees authorized by the candidate in connection with a previous or subsequent Federal election.

NET DISBURSEMENTS:

This column shows the actual disbursements made by committees authorized for a particular 1988 primary campaign. It is equal to the total disbursements reported by those campaign committees minus any transfers they have made to each other. ("Transfers", reported on Line 24 of Schedule B, are the movement of money, goods, property or services between authorized committees.) Note that, if a 1988 primary campaign committee transfers funds to a joint fundraising committee or to a campaign committee that was

authorized by the candidate for another Federal campaign, the transaction is regarded as a disbursement to another non-campaign committee, not as an internal transfer.

ITEMIZED LOAN REPAY. TO CANDIDATE:

This figure is the amount of itemized loan repayments which the campaign has made to the candidate. Information is from Line 27a of Schedule B.

OTHER LOAN REPAYMENTS:

This column shows loan repayments to individuals, to political committees which are not part of the campaign, to organizations which are not registered under the Federal Election Campaign Act, and to banks for loans previously made in the ordinary course of business. Line 27b, Column A is the source.

INDIV CONTRIB REFUNDS:

This column gives the total amount of contributions the campaign has reported refunding to individuals. This information is reported on Line 28a, Column A.

PARTY CONTRIB REFUNDS:

This column represents refunds of contributions originally made by party organizations as reported on Line 28b, Column A. Note that some of these party organizations may not be registered as political committees with the Federal Election Commission.

NON-PARTY CONTRIB REFUNDS:

This column shows refunds of contributions originally made to the campaign by non-party political committees. The information is as reported on Line 28c, Schedule B.

OTHER CONTRIB REFUNDS:

This column gives contribution refunds made to committees or organizations not included in the previous two columns. They may be campaign committees of other candidates or committees authorized for a previous or future federal election. The value is derived by subtracting from the total reported on Line 28c, Column A, all non-party committee refunds shown in the previous column.

OPERATING EXPEND:

This column shows the sum of all operating expenditures reported by the campaign on Line 23, Column A.

EXEMPT FUNDRAISE DISBURSE:

Disbursements made for certain fundraising activities which are reported on Line 25, Column A. Those candidates accepting public funding may spend up to 20% of the overall expenditure limit on fundraising activities without having these

disbursements count against the overall limit (see 2 U.S.C Section 431 (9) (B) (vi)). Note that the cost of some fundraising activity may be included on Line 23 as operating expenditures. If so it is not considered exempt from expenditure limitations.

EXEMPT LEGAL/ACCT DISBURSE:

Disbursements made for legal and accounting services related to compliance with the requirements of the Federal Election Campaign Act of 1971 as amended are exempt from overall expenditure limitations set forth in the act. (2 U.S. C. Section 431 (9) (B) (vii)). The information is as reported on Line 26, Column A. Note that the cost of some compliance related legal and accounting activity may be included on Line 23 as operating expenditures. If so, it is not considered exempt from expenditure limitations.

OTHER DISBURSE:

Included here are other miscellaneous disbursements including, for example, contributions by the campaign to other committees, loans made by the campaign, etc. The information is reported on Line 29, Column A.

TABLE A7 - ADJUSTED DISBURSEMENTS

OPERATING EXPENDITURES MINUS OFFSETS:

The sum of all operating expenditures reported by the campaign on Line 23, Column A minus the sum of any offsets to operating expenditures reported on Line 20a, Column A.

EXEMPT FUNDRAISE DISBURSEMENTS MINUS OFFSETS:

The sum of all fundraising disbursements as reported on Line 25, Column A minus any offsets to those disbursements reported on Line 20b, Column A.

EXEMPT LEGAL/ACCT DISBURSEMENTS MINUS OFFSETS:

The sum of disbursements for legal and accounting activities as reported on Line 26, Column A minus any offsets to these reported on Line 20c, Column A.

OTHER DISBURSEMENTS:

The sum of disbursements not included in other categories, excluding transfers among authorized committees within the campaign. Included here, for example, are contributions to political committees outside the campaign or loans made by the campaign. This information is reported on Line 29, Column A.

EXPENDITURES SUBJECT TO LIMIT:

This column shows expenditures that the campaign has reported as being subject to the limitations of the Act (2 U.S.C. Section 441a(b)). The figure is equal to net operating expenditures

plus any fundraising disbursements in excess of 20% of the overall expenditure limit and is reported on Line 13 of the most recent report.

LATEST CASH ON HAND:

This column gives each campaign's "cash-onhand" as reported at the close of the most recent reporting period (Line 10).

DEBTS OWED BY CAMPAIGN:

Outstanding debts and obligations owed by the campaign are shown here as reported on Line 12 of the most recent report.

The value in this column for Alan Cranston represents only outstanding loans and does not include debts and obligations to vendors.

DEBTS OWED TO:

Outstanding debts and obligations owed to the primary campaign as reported on Line 11 of the most recent report.

TABLE A8 - EXPENDITURES, DISBURSEMENTSAND COMMUNICATIONS COSTS BY OTHERS

INDEP EXPEND FOR CAND:

The figure here shows independent expenditures advocating the election of a clearly identified candidate registered with the Commission made by persons or groups other than political committees. (Independent expenditures are expenditures for communications which are made expressly to advocate the election of a clearly identified candidate but which are not made with the cooperation of, or in consulation with, the candidate or his/her agents or authorized committees.) A mounts included in this column were spent during the period the candidate was actually a registered candidate. Information was taken from FEC Form 5 filed by persons making the expenditures.

N/P EXPEND FOR:

This column includes independent expenditures (as defined above) made on behalf of a clearly identified candidate by non-party political committees. (A non-party committee means any committee that has not been authorized by any candidate and is not part of the official party structure at the national, State, or local level, which has registered as a political committee under the Federal Election Campaign Act as amended.) The information is reported by the non-party committees on Line 22 of Schedule E of FEC Form 3X.

DELEGATE/DELEGATE COMM DISBURSE FOR (Delegate/Delegate Committeee Disbursements for the Campaign):

Shown here are total disbursements (all outgoing monies, goods and services) of delegate and delegate-committee filers which are financially unauthorized by the campaign but which have indicated on FEC Form 1 that they advocate the election of only this candidate.

COMMUNICATION COSTS FOR:

This column shows the total amount of treasury funds spent by corporations, labor unions and other membership organizations to make internal communications which advocate the election of a clearly indentified candidate.

These communications may be made only to certain categories of individuals (i.e., by a corporation, to its stockholders or executive and administrative personnel, or by a membership organization (including a union) to its members). The corporation or membership organization is not required to report these costs to the Commission on FEC Form 7 until they exceed \$2,000 per election. Thereafter, each additional communication cost is also reported.

INDEP EXPEND AGAINST CAND:

The figure here shows independent expenditures advocating the defeat of a clearly identified candidate registered with the Commission made by persons or groups other than political committees. (Independent expenditures are expenditures for communications which are made expressly to advocate the defeat of a clearly identified candidate but which are not made with the cooperation of, or in consulation with, the candidate or his/her agents or authorized committees.) A mounts included in this column were spent during the period the candidate was actually a registered candidate. Information was taken from FEC Form 5 filed by persons or groups making the expenditures.

N/P EXPEND AGAINST:

This column includes independent expenditures (as defined above) advocating the defeat of a clearly identified candidate by non-party political committees. (A non-party committee means any committee that has not been authorized by any candidate and is not part of the official party structure at the national, State, or local level, which has registered as a political committee under the Federal Election Campaign Act as amended.) The information is reported by the non-party committees on Line 22 of Schedule E of FEC Form 3X.

COMMUNICATION COSTS AGAINST:

This column shows the total amount of treasury funds spent by corporations, labor unions and other membership organizations to make internal communications which advocate the defeat of an identified candidate.

These communications may be made only to certain categories of individuals (i.e., by a corporation, to its stockholders or executive and administrative personnel, or by a membership organization (including a union) to its members). The corporation is not required to report these costs to the Commission on FEC Form 7 until they exceed

\$2,000 per election. Thereafter, each additional communication cost is also reported.

TABLE A9-STATE-BY-STATE EXPENDITURES

STATE EXPEND LIMIT:

This column shows current expenditure limits for each State, the District of Columbia, the Commonwealth of Puerto Rico and U.S. territories or possessions. 2 U.S.C. Section 441a(b) limits not only the total amount of expenditures which a candidate eligible to receive Federal matching funds may make, but also the amount which may be expended in any one State.

TOTAL EXP TO DATE:

This column shows total expenditures made in a State which are subject to the State limitation. Information is from FEC Form 3Pc.

CAMPAIGNS:

There is a separate page for each of the campaigns receiving (and retaining) contributions from party or non-party political committees. Another page summarizes TABLE D activity for all campaigns included in this volume.

DATE CONTRIBUTION RECEIVED:

This row indicates the date on which the campaign received the contribution (or made the refund of a contribution). Because contributions or refunds of contributions with incomplete dates cannot be placed within a specific date range, they are included in the final category labeled "after 6/30/88."

POLITICAL COMMITTEE TYPE:

NET CONTRIBUTIONS means the amount of contributions (donations of money, services, goods or property) received and actually retained by a campaign. It is equal to the total contributions reported by all the committees authorized for a 1988 primary campaign, minus any itemized contributions the campaign has returned to

contributors. Such refunds of contributions might occur when a candidate decides not to accept contributions from certain types of political committees.

The TABLE categorizes political committees their relationship to to other according organizations. Non-party committees are grouped under the following organizational categories: committees connected to corporations; to labor organizations; to trade, membership and health organizations; to cooperatives; and to corporations without stock; committees with no connected organization. (A non-party committee means any committee that has not been authorized by any candidate and is not part of the official party structure at the national, State or local level, which has registered as a political committee under the Federal Election Campaign Act, as amended.) Also shown are party committees-committees that are part of the official party structure at the national, State or local level which have registered as political committees under the Federal Election Campaign Act, as amended.

The dollar (\$) portion of each column shows the net contributions which a campaign has received (and retained) from the particular type of political committee during the specific range of dates.

For the six non-party political committee types the percent (%) segment of the column indicates what portion of net non-party committee contributions received during the specific time period came from that type of committee.

TABLEC–IN DIVIDUALCONTRIBUTIONSAGGREGATEDBYSTATE:IN DIVIDUALCONTRIBUTIONSOF \$500-AND-UP AGGREGATEDBYSTATETODIFFERENTCAMPAIGNBY

CAMPAIGNS:

The campaigns each have a separate column. As used in this study, contributions, from individuals include monies given directly to the campaign or earmarked through another political committee and in-kind contributions of services, goods or property. Checks for individual contributions that banks returned to the campaign because of "non-sufficient funds" have been reported, by some campaigns as negative receipts and thus netted out of the total amount of individual contributions.)

Itemized contributions are those which have been identified separately on reports, disclosing the name and address of the contributor, his/her place of business/name of employer and the amount and Under the Federal date of the contribution. Election Campaign Act of 1971, as amended, contributions from individuals have to be itemized if they exceeded (in the aggregate) \$200 per candidate, per year. (Once an individual donor's contributions to a candidate exceeded this amount, all subsequent contributions to the same candidate had to be itemized. This Table, however, provides information for only itemized contributions of \$500 or more because of Commission policy concerning data entry into its computer system.

The number (#) portion of the column shows the number of itemized individual contributions of \$500 or more a campaign has received from a particular State. State identification is based on the contributor's address as reported by the campaign.

The dollar (\$) portion of the column shows the total amount of such itemized individual contributions.

The percent (%) shows what portion of such itemized individual contributions received by a campaign came from a given state.

ADDRESS OF CONTRIBUTOR:

This row shows the State identified in the individual contributor's address.

If the State address of a contribution is incomplete, the contribution is placed in the final row, "no state."

TABLE D - NET RECEIPTS OF CAMPAIGN BY TIME PERIOD

CAMPAIGNS:

The campaigns are listed alphabetically within their respective parties. The candidate's party is reported on the Statement of Candidacy filed with the Commission.

TIME PERIODS:

The time periods listed coincide with coverage periods of reports required of Presidential candidates. The first column, "PRIOR TO 4/1/87", however, includes all activity appearing on reports up to and including the first quarterly report in 1987.

NET RECEIPTS:

Net receipts are the actual receipts of all committees authorized for a particular 1988 primary campaign. They are equal to the total receipts reported by the committees during a particular time period minus any transfers they have received from each other during that period.

TABLE E - TOTAL INDIVIDUAL CONTRIBUTIONS BY TIME PERIOD

CAMPAIGNS:

The campaigns are listed alphabetically within their respective parties. The candidate's party is reported on the Statement of Candidacy filed with the Commission.

TIME PERIODS:

The time periods listed coincide with coverage periods of reports required of Presidential candidates. The first column, "PRIOR TO 4/1/87", however, includes all activity appearing on reports up to and including the first quarterly report in 1987.

TOTAL INDIVIDUAL CONTRIBUTIONS:

This figure represents all itemized and unitemized contributions from individuals, as reported on Line 17a. (Note: Checks for individual contributions returned to the campaign because of insufficient funds have been reported by some campaigns as negative receipts and so have been removed from these totals. Other refunds of individual contributions, reported as disbursements, are not taken into consideration here.)

The value beneath the amount represents individual contributions as a proportion of net receipts for the time period.

TABLE F - TOTAL LOANS RECEIVED BY TIME PERIOD

CAMPAIGNS:

The campaigns are listed alphabetically within their respective parties. The candidate's party is reported on the Statement of Candidacy filed with the Commission.

TIME PERIODS:

The time periods listed coincide with coverage periods of reports required of Presidential candidates. The first column, "PRIOR TO 4/1/87", however, includes all activity appearing on reports up to and including the first quarterly report in 1987.

TOTAL LOANS RECEIVED:

This figure represents loans received by the campaign from all sources during the specified time period. The information is as reported on Lines 19a and b, Column A, of reports covering each time period.

The value beneath the amount equals total loans as a proportion of net receipts for the time period.

TABLE G - FEDERAL MATCHING FUNDS BY TIME PERIOD

CAMPAIGNS:

The campaigns are listed alphabetically within their respective parties. The candidate's party is reported on the Statement of Candidacy filed with the Commission.

TIME PERIODS:

The time periods listed coincide with coverage periods of reports required of Presidential candidates. This table will be included in Reports covering activity occurring in 1988.

FEDERAL MATCHING FUNDS:

The amount of Federal matching funds certified by the FEC and reported by the campaign as having been received in the specified time period.

Note that while individual contributions received in 1987 are eligible for matching funds, no Federal funds are distributed until after January 1, 1988.

The value beneath the amount represents matching funds as a proportion of net receipts for the time period.

TABLE H - NET DISBURSEMENTS BY TIME PERIOD

CAMPAIGNS:

The campaigns are listed alphabetically within their respective parties. The candidate's party is reported on the Statement of Candidate filed with the Commission.


TIME PERIODS:


Presidential Pre-Nomination Campaign Receipts By Source and Time Period Democrats



Presidential Pre-Nomination Campaign Receipts By Source and Time Period Democrats (in Millions of Dollars)






Appendix II Expenditures Subject to Limit by Reporting Period and the Overall Spending Limit






