#### II. DRAFT ADVISORY OPINION 2018-12 (continued)

Chair Weintraub recognized Mr. Joseph Wenzinger of the General

Counsel's Office who presented the draft advisory opinion request from

Defending Digital Campaigns, Inc. The requestor asks whether it may provide or
facilitate the provision of certain cybersecurity services, software, and
hardware to federal candidate committees and national party committees on a
nonpartisan basis and according to pre-determined, objective criteria. Draft A

concludes that the proposal is permissible because the provision of the services
described in the request would not be made for the purpose of influencing a
federal election or in connection with a federal election, and thus would not
constitute a prohibited in-kind contribution. Draft B concludes that the proposal
is impermissible because the provision of the services provided in the request
would be in connection with a federal election and thus would constitute a
prohibited in-kind contribution.

Mr. Toner, Mr. Rhoades, Mr. Mook, and Mr. Elias participated in the discussion that followed.

Chair Weintraub suggested that the Commission consider the remaining two (2) advisory opinions on the meeting agenda and then recess until

approximately 2:00 P.M. to allow time to review an alternative draft to see if the Commission can find consensus. Discussion followed and Mr. Toner requested a recess in order to confer with his colleagues.

### IV. DRAFT ADVISORY OPINION 2019-04

Prytany LLC by Jeffry Hardin, Esq.

Agenda Document No. 19-13-A (Draft A)

Chair Weintraub recognized Mr. Jeffry Hardin, requestor's counsel, who was available to answer Commissioners' questions.

Chair Weintraub recognized Mr. Kevin Paulsen of the General Counsel's

Office who presented the draft advisory opinion request from Prytany LLC,

which has developed an online contribution processing platform that enables

users to make contributions to principal campaign committees and national

political party committees. The requestor asks several questions regarding the applicability of the Act and Commission regulations to its activity. The draft concludes that both the provision of contribution processing services by Prytany to individual users and enrolled political committees, as well as the provision of social networking services to enrolled political committees do not result in contributions by Prytany to the recipient committees because Prytany satisfies the criteria to qualify as a commercial vendor. Specifically, Prytany renders its services in the ordinary course of business, aimed at the usual and normal charge for such services. It forwards contributions to political committees through segregated accounts and employs adequate screening procedures to ensure that it is not forwarding illegal contributions. The draft further concludes that because Prytany will be acting as a commercial fundraising firm, it is not subject to any of the reporting requirements under the Act. Finally, the draft concludes that Prytany's practices, as described in the request, comply with the applicable forwarding requirements.

Mr. Hardin participated in the discussion that followed and thanked Office of General Counsel staff for their assistance.

**Chair Weintraub recognized Vice Chairman Petersen who** 

MOVED to approve Agenda Document No. 19-13-A, otherwise known as Draft A.

The motion carried by a vote of 4-0 with Commissioners Hunter, Petersen, Walther, and Weintraub voting affirmatively for the decision.

#### V. DRAFT ADVISORY OPINION 2019-06

Leigh Brown by Jessica Johnson, Esq. and Jason Torchinsky, Esq.

Agenda Document No. 19-14-B (Draft B) (Submitted Late)

Chair Weintraub recognized Ms. Jessica Johnson and Mr. Jason

Torchinsky, requestor's counsel, who were available to answer Commissioners'

questions.

Chair Weintraub recognized Ms. Joanna Waldstreicher of General

Counsel's Office who presented the draft advisory opinion request from Leigh

Brown, who is a candidate in the upcoming special election for North Carolina's

Ninth Congressional District, for which the electioneering communications

period will begin on April 14th. Leigh Brown & Associates is a for-profit real

estate business incorporated in North Carolina. Ms. Brown has recorded radio

ads for the business that identify her by name but make no reference to her

candidacy. Her requests asks whether these existing ads may be exempted

from the definition of electioneering communication or, if not, whether

proposed alternate versions of the ads would be electioneering

communications. Draft A concludes that the existing versions of the ads are

not entitled to an exemption from the definition because they are not plainly and unquestionably not related to the election. Draft B concludes that the existing versions of the ads are entitled to an exemption because they do not promote, support, attack, or oppose any candidate and they are plainly and unquestionably not related to the election. Both drafts conclude that the alternate versions of the ads would not be electioneering communications because they do not contain unambiguous references to a clearly identified federal candidate.

Mr. Torchinsky and Ms. Johnson participated in the discussion that followed.

Commissioner Hunter asked Mr. Torchinsky if it would be helpful to have an advisory opinion regarding the ads being voiced by someone other than the candidate. Mr. Torchinsky requested a recess so that he might confer with his client.

Discussion followed on the motion.

three, as set forth in Agenda Document No. 19-14-A,

Draft A.

The motion failed by a vote of 3-1 with Commissioners Hunter, Petersen,

and Walther voting affirmatively for the motion. Commissioner Weintraub

dissented.

Mr. Torchinsky requested to receive the close out letter this afternoon so

that they could go to court prior to the electioneering communications window

beginning this weekend. Mr. Neven Stipanovic of the General Counsel's Office

confirmed that his office would accommodate the request.
