I find the electronic view and download files to be convenient, but the printed images generate an astonishingly large number of pages relative to the information on them. A paper listing that looking like the electronic image would be progress, in my opinion, or at least save a few trees.

During my own campaign (Libertarian, for our party's Presidential nomination) I would occasionally get odd questions about financial information, from people who had gone someplace else on your web site.

It appeared that they had gone to Campaign Finance Reports and Data -> Search the Disclose Database -> Candidate Search, and someplace from there. Alas, this never came up while we had a computer handy, so I cannot be more precise. In any event, they were coming up with donation and expenditure numbers that were not at all correct, uniformly too small. It appeared as though the quoted numbers, for a Presidential campaign, only referred to the current Congressional cycle, but I could be wrong. Perhaps this was a deliberate feature, but it confused people. Sorry I am being so very vague about the details.

> I am very pleased to announce that the Commissioners voted today to launch a new initiative seeking public input and advice on ways in which the Commission might improve its website and, more generally, make improvements in the Commission's use of the Internet to communicate with the public.

> The FEC was first constituted in 1975. The Commission launched its first website in 1996 and is now, for the first time, seeking formal public recommendations on the means by which the FEC discloses information to the public. The Commission desires to learn how it can improve its website to ensure that it is a state-of-the-art resource for disclosure of information to the public including (1) disclosure of campaign finance data, (2) information about federal campaign finance laws and (3) actions of the Commission.

> As part of this initiative, the FEC is seeking suggestions and recommendations from all segments of the public, including representatives of political committees, Federal candidates and officeholders, members of the media, authors, students, members of the academic community and advocacy groups.

> Many of you may have turned to the Commission's website in the past for information and have either found that the information is not organized intuitively, or that you were unable to access the information easily, or that the information you sought was not available on the FEC website at all. This is the type of feedback that only you, the public users of our website, can provide. That is why I am writing to you personally to ask you to consider participating in this important initiative by sending us your comments about what improvements we can make.

> We request that comments be sent to us by July 21, 2009. You can e-mail them to [improvefecinternet@fec.gov](mailto:improvefecinternet@fec.gov) . After we receive all the public comments, the Commission will hold a public hearing on these issues on Wednesday and Thursday, July 29-30, 2009.
